## State Board of Elections and Ethics (NCSBE) Transition

The passage of S.L. 2016-125 and subsequent passage of S.L. 2018-2 which became law on March 16, created a new nine-member Bipartisan State Board of Elections and Ethics Enforcement Board. The new State Board oversees the elections process, as well as campaign finance, ethics and lobbying disclosure and compliance in North Carolina.

The transition will include the transfer of the lobbying registration and enforcement functions (Chapter 120C) from the Secretary of State to the new Board. NCPLA has been meeting with both the Secretary of State's office and the State Board of Elections and Ethics Enforcement to work toward a smooth transition.

## NCGA Building Security

Legislative building security is now installed and will be a new normal for the short session. Over the course of the last year, NCPLA has been proactive about meeting with the Legislative Services Office (LSO) and others to discuss the effects of building security on NCPLA members performing their daily job functions. In researching best practices in other states, many offer an expedited entry option for government relations professionals and other frequent visitors. This has been a primary focus for NCPLA.

The security team at the NCGA has visited and researched many other state practices, but currently the only individuals with security badges will be legislators and staff working inside the General Assembly. NCPLA is continuing to meet with the LSO and other key decision-makers to provide feedback and continue to explore options for a more streamlined process for those that frequent the legislative building on a regular basis. While security is planned for the LOB in the future, the LSO does not have a timeline for installation in the LOB.

In the meantime, allow additional time for security not just in the morning but in between buildings. We recognize the adjustments and challenges this presents in performing our jobs in the way in which we are accustomed but ask for your patience and feedback.

## NCGA Security FAQs

### What is scanned by the X-ray machine?

Scans will be conducted on purses, briefcases, backpacks, strollers, small parcels, etc. The X-ray machines will detect weapons, explosives, and other contraband.

### What items are prohibited?

- Aerosol containers
- Electric stun guns, martial arts weapons or devices
- Knives of any size
- Guns, replica guns, ammunition and fireworks
- Any weapon facsimile
- Razors and box cutters
- Pets or animals (service animals are permitted)
- Batons and nightsticks
- Any other items or device that can be considered a dangerous weapon

### Will LB entries changes?

- Access will be restricted to the main front and back entrances of the building.
- Each entrance will have two points of entry – one with a turnstile for legislators and staff to enter with badges and the other with a metal detector for screening.
- The cafeteria & snack bar will remain accessible once inside the legislative building but no longer through the parking garage.
